The St. Marys Community Foundation was established in 1974 by a group of public-spirited citizens of St. Marys. Their purpose was to create a charitable organization that would receive gifts and distribute funds to help the St. Marys community meet religious, scientific, literary, educational, recreational and charitable goals.

Organization

The St. Marys Community Foundation is a 501(c) 3 non profit charitable organization. Donations are accepted for either general or specific charitable, benevolent or educational purposes. The Directors of the St. Marys Community Foundation are pleased to present this 2015-2016 Annual Report. At the end of the 2015-2016 year ending June 30, 2016, the Foundation had assets of over \$5.95 million in 112 diverse funds to benefit the St. Marys community. Donations to community groups and organizations and scholarship grants were awarded in 2015-2016 in the total amount of \$422,287. This report is intended to show that the Foundation is truly meeting its goal of providing a means for donors to give back to the community to help improve the quality of life in the St. Marys area.

SCHOLARSHIPS AND LOANS

A large number of funds with the Foundation provide scholarships and loans for higher education. In 2015-2016 there were Scholarship Grants in the amount of \$94,360 awarded to students attending school beyond high school. Low interest Education Loans in the amount of \$158,500 were also awarded to students to help them with their education. Since 1978 the St. Marys Community Foundation has awarded a total of \$1,087,835 in Scholarship Grants and \$ 2,156,045 in loans. The total student loans receivable to be repaid to the Foundation as of June 30, 2016 is \$706,875. Applications for loans and scholarships are available in February for the following school year with completed scholarship applications due by April 1st and loan applications due June 1st.

WAYS TO CONTRIBUTE

Making a donation to the Foundation is a way to give back to the St. Marys community. The St. Marys Community Foundation offers flexible ways to help organizations while helping the donor enjoy the most favorable tax treatment permitted by law. Many funds distribute only income from interest earned while others distribute principal and interest. This is determined when the fund is created or through the suggestions of fund advisors. There are many ways to include the St. Marys Community Foundation in your charitable gifts plans. Funds that can be established with the Foundation may include Unrestricted Funds, Restricted Funds, Donor Advised Funds, Field of Interest Funds, Endowment Funds and Scholarship Funds.

A donor may wish to include the St. Marys Community Foundation in his/her will so the donation will not be subject to estate or inheritance tax. Donors are invited to add to any of the funds already established or start a new fund that will benefit the citizens of the St. Marys community. It would be best to consult with a financial, tax or legal advisor when contemplating a large gift to the St. Marys Community Foundation.

APPLYING FOR A GRANT

If your non-profit organization works to provide a better future for individuals or the St. Marys community at large, you are invited to request assistance through the St. Marys Community Foundation. A Grant Application is available for non-profit groups to request financial assistance through the Foundation. All documentation supporting the grant request must be provided so it can be given thorough consideration. The grant request can begin by submitting a letter to the Foundation office.
